**ANC 3F Resolution Regarding First Vine Application  
for a Stipulated Retailer's Class A Online License**

WHEREAS First Vine, LLC ("Applicant") has applied for a substantial change to its Retailer's Class A Online liquor license (ABRA-075977) to transfer from 1701 Florida Avenue, NW, to 4221 Connecticut Avenue, NW; and

WHEREAS the Applicant has posted the placard announcing the application for a substantial change to its license, with a petition date of April 11, 2016, and a hearing date of April 25, 2016; and

WHEREAS the Applicant wishes to start selling alcohol before the hearing date, for which it will need a stipulated license; and

WHEREAS the Applicant has expressed an intent to use off-street parking for dropping off and retrieving wine and to maintain the establishment in such a manner as to have minimal impact on vehicular and pedestrian traffic in the neighborhood;

THEREFORE, BE IT RESOLVED that ANC 3F supports the Applicant's request for a stipulated license and supports the issuance of a substantial change to its Class A Online license.

ANC 3F approved this resolution by a vote of six in favor, none opposed, and none abstaining from voting (6-0-0) at its March 15, 2016, meeting, which was properly noticed and at which a quorum was present. Commissioner Adelstein is delegated the authority to represent ANC 3F in this matter.
